CATEGORIES:

2-Dimensional and 3-Dimensional works in all media are eligible, including drawing, painting, photography, mixed media, sculpture and ceramics.

- 2-Dimensional: Works must not exceed 50 inch perimeter. Acceptable sizes for two-dimensional works: 5x7, 8x10, 9x12, and 11x14. Frames must be sized appropriately to suit the work of art. Otherwise, if the frame is too large, the work will be rejected.
- 3-Dimensional: All works MUST fit into a 6-inch square box.
- Works that have been in previous exhibitions at PVAC are not eligible. Works must have been made within the past two years.

FEES:

- Maximum of three entries at \$8 per entry (non-refundable fee). PVAC is not responsible for lost, stolen or misdirected entries.
- Make checks payable to Palos Verdes Art Center.
- PVAC will take a 25% commission on all sales of exhibited work.

CALENDAR:

- Delivery of artwork: Friday, July 30, 10 am–noon
- Critique of accepted works: 2 pm
- Pick up of unaccepted works: 3–4 pm

DELIVERY:

Artwork must be hand delivered to the Palos Verdes Art Center patio on Friday, July 30 from 10 am–noon. The work will be reviewed by our juror. Accepted art will remain; not accepted work will be available on the patio for pick up after 3 pm.

EXHIBITION:

Accepted artwork will be exhibited August 6–October 3, 2010.

ENTRY PROCEDURE:

1. Complete top and bottom of entry form and sign. (Please print legibly.)
2. Incomplete applications will not be reviewed.
3. Include check or money order, payable to PVAC.
